MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Michael Rabinovitz, et al. v. City of Los Angeles, et al., United States District Court Case No. CV 16-8087 DMG (JPRx) (this matter arises from an incident involving members of the Los Angeles Police Department on May 21, 2015, in Los Angeles, California), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to expend up to \$500,000 in settlement of the above-entitled matter.
2. AUTHORIZE the Controller to transfer \$500,000 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009792, Police Liability Payouts.
3. AUTHORIZE the City Attorney to draw demands from Fund No. 100/59, Account No. 009792, Police Liability Payouts as follows:
 - a. \$370,000 made payable to Law Office of Donnie R. Cox and Michael Rabinovitz.
 - b. \$130,000 made payable to Structured Assignments, Inc. to fund future periodic payments to Micaela Rabinovitz, a minor.
4. AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.
