Subject: AUTHORITY TO APPROVE THE OFFICE OF COMMUNITY BEAUTIFICATION CONTRACT TERM EXTENSIONS WITH CONTRACTORS PROVIDING GRAFFITI REMOVAL AND COMMUNITY BEAUTIFICATION SERVICES WITHIN THE CITY OF LOS ANGELES

As recommended in the accompanying report of the Office of Community Beautification, which this Board has adopted as amended, the Board of Public Works recommends that your Honorable Body provide authority to extend the team of various OCB contracts used for graffiti removal and community beautification services from three years ending June 30, 2016 to four years ending June 30, 2017, with a one year renewal option for the following contractors:

**FISCAL IMPACT**

Funding for each contract is determined by required services and funding approved by City Council through the City's budget adoption process. Funding for these projects is then established and approved by the Board of Public Works at the start of each Fiscal Year. Approval of the proposed action will allow the Board of Public Works to extend the contract term of each respective contract with OCB contractors to provide graffiti removal and community beautification services, among other services.
