The Planning Department works with the City Attorney's Office to draft Ordinances for Planning related items. You might want to contact the Planning Department and ask who the Planner is handling Accessory Dwelling Units. I believe the Planning Department does outreach to the community for input. You can also contact the City Attorney's Office, Land Use Division to inquire the status of the Ordinance. When the Ordinance is ready for Council to approve, the item will be scheduled for the PLUM Committee first. PLUM will then make a recommendation for Council consideration. The item is then scheduled for Council, whose has the final vote on approving or disapproving the Ordinance. If Council approves, the Ordinance goes to the Mayor for signature (in which the Mayor has 30 days to sign). Once the Mayor signs, the Ordinance will go into effect 41 days after the Ordinance is posted.
