

MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations in order to effect settlement in the case entitled Clifford Anderson, et al. v. City of Los Angeles, United States District Court Case No. CV16-00187 JFW (FFM) (this matter arises from wage and hour litigation pursuant to the Fair Labor Standards Act involving members of the Los Angeles Fire Department), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of **\$1,734,320.19** in settlement of the above-entitled matter.
2. AUTHORIZE the Controller to transfer \$896,208.12 from Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009790, Fire Liability Payouts.
3. AUTHORIZE the City Attorney draw demands from Fund No. 100/59, Account No. 009790, Fire Liability Payouts as follows:
 - a. Liquidated damages in the amount of \$838,112.07 made payable to: The Woodley and McGillivray Client Trustee account.
 - b. Attorneys’ fees and costs in the amount of \$58,096.05 made payable to: Woodley and McGillivray, LLP.
4. AUTHORIZE the Los Angeles Fire Department to pay overtime wages in the amount of \$838,112.07 from Fund No. 100/38, Account No. 001012, as set forth in Exhibit A attached to this Motion
5. AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.

This matter was recommended for approval by the Budget and Finance Committee (Krekorian – Englander – Martinez – Blumenfield – Bonin: “Yes”) at its meeting on April 3, 2017, in Closed Session as permitted by Government Code Section 54956.9(d)(1).
