PUBLIC SAFETY COMMITTEE REPORT relative to the Supplemental Police Account (SPA) Fourth Quarterly Report (October through December 2017).

Recommendation for Council action:

NOTE and FILE the SPA Fourth Quarterly Report dated March 20, 2018, attached to the Council file, relative to the status and activities of the SPA for the period October through December 2017.

SUMMARY

At the meeting held on April 11, 2018, your Public Safety Committee considered a Board of Police Commissioners (Board) report relative to the SPA Fourth Quarterly Report (October through December 2017). The Board reports that Attachment I of the SPA report is a statistical recapitulation of Information/Contraband line item expenditures under the miscellaneous operational expenses category showing 17 SPA expenditures in which drugs or assets were seized. These expenditures resulted in 19 arrests and the seizure of \$8,131 in United States currency. Also seized were 8,386,27 grams of narcotics. Any seized or forfeited property that was placed into service by the Los Angeles Police Department during this Quarter will appear on this attachment. Attachment II is a year-to-date comparison of SPA seizures for the last five years. Attachment III is a report from Fiscal Operations Division detailing expenses incurred from the Council-approved expenditure plan by the appropriation account. Attachment IV is a Fact Sheet briefly describing the SPA. After an opportunity for public comment was held, the Committee recommended that Council note and file the SPA Fourth Quarterly Report, inasmuch as the report is submitted for information only and no further Council action is necessary. This matter is now forwarded to the Council for its consideration.
