PUBLIC WORKS AND GANG REDUCTION COMMITTEE REPORT relative to monitoring the condition of the City's streets and sidewalks.

Recommendation for Council action, pursuant to Motion (Krekorian - Ryu - Martinez for O'Farrell - Blumenfield):

INSTRUCT the Bureau of Street Services (BSS) to report on:

- a. A set of policies and procedures to more efficiently monitor known conditions in the City's streets and sidewalks that could be potentially dangerous, identify the appropriate mitigations to improve threats to public safety resulting from them, and track the progress at implementing those mitigations.
- b. Criteria for assessing the severity of conditions that could be potentially dangerous, including a threshold for when the BSS will, either at its own discretion or upon a report to Council, redirect staff and construction resources away from work that is less critical for public safety, or consider adding the services of contractors to meet the demand for repairs.
- c. Appropriate budgetary performance metrics for assessing the BSS's performance at resolving threats to the safety of the public in its use of the City's streets and sidewalks, and a strategy to begin measuring that performance beginning in the 2018-2019 Fiscal Year. Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At the meeting held on March 21, 2018, your Public Works and Gang Reduction Committee considered a Motion (Krekorian - Ryu - Martinez for O'Farrell - Blumenfield) relative to a instruction to the BSS to report on: policies and procedures to more efficiently monitor City streets and sidewalks and identify and mitigate dangerous conditions, criteria for assessing the severity of dangerous conditions, and appropriate budgetary performance metrics for assessing BSS' performance in resolving threats to public safety and a strategy to begin measuring that performance beginning in Fiscal Year 2018-19. After an opportunity for public comment was held, the Committee moved to approve the recommendation contained in the Motion, as detailed above. This matter is now forwarded to the Council for its consideration.
