
**THE PEOPLE OF THE CITY OF LOS ANGELES

- Sec. 6. Ordinance No. 107,271, adopted March 29, 1956, is hereby repealed.
- Sec. 7. Ordinance No. 108,896, adopted January 31, 1957, is hereby repealed.
- Sec. 8. Ordinance No. 110,625, adopted December 10, 1957, is hereby repealed.
