

I MOVE that the Council ADOPT the following recommendations with respect to request for determination of "Public Convenience or Necessity" Application for the sale of alcoholic beverages, for off-site consumption at The Consort located at 438 South Main Street, Los Angeles, CA 90013 in Council District 14 on today's Council Agenda (Item 1, Council File No. 17-1294), pursuant to AB 2897 (Caldera) and required Findings by the State Department of Alcoholic Beverage Control under Business and Professions Code Sections 23958 and 23958.4:
