BUDGET AND FINANCE COMMITTEE REPORT and ORDINANCE FIRST CONSIDERATION relative to the creation of a City Attorney Community Justice Initiative Trust Fund.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE, dated December 14, 2017, adding Article 31 to Chapter 5 of Division 5 of the Los Angeles Administrative Code (LAAC) to provide for the creation of the City Attorney Community Justice Initiative Trust Fund.

Fiscal Impact Statement: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

### SUMMARY

At its regular meeting held on January 22, 2018, the Budget and Finance Committee considered a City Attorney report and draft Ordinance relative to amending the LAAC for the creation of a City Attorney Community Justice Initiative Trust Fund. The City Attorney reports that the purpose of the Fund is for the deposit and disbursement of local, state, and federal funds as well as gifts, contributions, and bequests, for the support of the City Attorney's Community Justice Initiative, a community-based partnership whose purpose is to engage the community in improving the criminal justice process. The Fund will sunset on December 12, 2024 and all monies remaining in the Fund at that time may be used for related neighborhood or public safety services.

After providing an opportunity for public comment, the Committee recommended that Council adopt the Ordinance creating the Community Justice Initiative Trust Fund. This matter is now forwarded to the Council for its consideration.
