TRANSPORTATION COMMITTEE REPORT relative to the establishment of parking restrictions on certain street segments in Council District Four.

Recommendations for Council action, pursuant to Resolution (Ryu - O'Farrell):

1. RESOLVE, pursuant to California Vehicle Code Section 22507, to hereby prohibit the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 10:00 pm and 6:00 am along the following street segments:
 - a. Wilcox Avenue between Fountain Avenue and De Longpre Avenue
 - b. Fountain Avenue between Wilcox Avenue and Cahuenga Boulevard
 - c. Cole Avenue between Fountain Avenue and Cahuenga Boulevard
 - d. De Longpre Avenue between Cahuenga Boulevard and Wilcox Avenue
2. DIRECT the Los Angeles Department of Transportation (LADOT), upon approval of this action, to post signs giving notice of a Tow Away, No Parking restriction for oversize vehicles on the streets listed above in Recommendation No. 1.
3. AUTHORIZE the LADOT to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

On January 24, 2018, your Committee considered a Resolution (Ryu - O'Farrell) relative to the establishment of parking restrictions along the following street segments in Council District Four:

- a. Wilcox Avenue between Fountain Avenue and De Longpre Avenue
- b. Fountain Avenue between Wilcox Avenue and Cahuenga Boulevard
- c. Cole Avenue between Fountain Avenue and Cahuenga Boulevard
- d. De Longpre Avenue between Cahuenga Boulevard and Wilcox Avenue

According to the Resolution, there is an increased problem with oversized vehicles parking on portions of Wilcox Avenue, Fountain Avenue, Cole Avenue and De Longpre in the Hollywood community, in the immediate vicinity of the Hollywood Police Station and Fire Department Station 27, which are often parked overnight and constrict travel lanes, thereby creating undesirable roadway conditions. After consideration and having provided an opportunity for public comment,

the Committee moved to recommend approval of the Resolution as detailed in the above recommendations. This matter is now submitted to Council for its consideration.
