MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Mario Granados v. City of Los Angeles, Los Angeles Superior Court Case No. BC582852 (this matter concerns a traffic collision involving a Los Angeles Police Department Officer), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to expend \$650,000 in settlement of the above-entitled matter.
2. AUTHORIZE the Controller to transfer \$650,000 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009792, Police Liability Payouts.
3. AUTHORIZE the City Attorney to draw a demand from Fund No. 100/59, Account No. 009792, Police Liability Payouts, in the amount of \$650,000 and made payable to the Law Offices of R. Thomas Wire and Mario Granados.
4. AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.
