SUBJECT: RESOLUTION NO. 18-8225 – PROPOSED SUCCESSOR PERMIT NO. 919 WITH H.S. SEAFOODS, INC.

Pursuant to Section 606 of the City Charter, enclosed for your approval is Resolution No. 18-8225 authorizing proposed Permit No. 919 with H.S. Seafoods, Inc.; which was approved at the January 11, 2018 meeting of the Board of Harbor Commissioners. Permit No. 919 is a successor term permit to Revocable Permit No. 12-19 and will allow H.S. Seafoods to occupy and use Port of Los Angeles' Stall 4 at the San Pedro Municipal Fish Market. Each tenant at the San Pedro Municipal Fish Market is now responsible for securing their own individual refrigeration system. Permit 919 is structured to allow H.S. Seafoods to finance the installation of a new individual refrigeration system for Stall 4. The term of Permit 919 will be eight years with two, one-year options to extend. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

1. ADOPT the determination by the Board of Harbor Commissioners (Board) that the proposed action is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with Article III, Class 1(14) of the Los Angeles City CEQA Guidelines;
2. APPROVE Harbor Department Resolution No. 18-8225 authorizing proposed Permit No. 919 with H.S. Seafoods; and
3. Return to the Board of Harbor Commissioners for further processing.
