PUBLIC WORKS AND GANG REDUCTION COMMITTEE REPORT relative to naming the private driveway lying on Pico Boulevard, between Olive and Hill Street, as Midway Lane; and changing the name of Midway Place, running between 12th Street and its southerly terminus, to Midway Lane.

Recommendation for Council action, pursuant to Motion (Huizar - Harris-Dawson):

INSTRUCT the City Engineer to begin the process of:

- a. Establishing the name of the private driveway lying on Pico Boulevard, between Olive and Hill Street, and continuing to a depth of 188.7 feet northerly toward 12th Street as Midway Lane.
- b. Changing the name of Midway Place, running between 12th Street and its southerly terminus, to Midway Lane.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At the meeting held on April 18, 2018, your Public Works and Gang Reduction Committee considered a Motion (Huizar - Harris-Dawson) relative to naming the private driveway lying on Pico Boulevard, between Olive and Hill Street, as Midway Lane; and changing the name of Midway Place, running between 12th Street and its southerly terminus, to Midway Lane.
