ARTS, ENTERTAINMENT, PARKS AND RIVER COMMITTEE REPORT relative to the termination of an existing 55-year lease (Contract No. C-104566) and the transfer to a 20 + 20 year Olvera Street Merchant Concession Agreement between the City and Georgina Rodriguez for Space C-4 on Olvera Street for an initial term ending June 30, 2031.

Recommendations for Council action:

1. APPROVE the transfer and termination of Contract No. 104566, an existing 55-year lease on Olvera Street, Space C-4, into a 20 + 20 year concession agreement and AUTHORIZE the General Manager, El Pueblo to enter into a Concession Agreement with Georgina Rodriguez for Space C-4.
2. APPROVE Contract Amendment No. 1, adding the following immediate family members per Section 12.1.1.1 of the Olvera Street Concession Agreement, Jennifer Rodriguez (Niece) and Michael A. Rodriguez (Grand-nephew).

Fiscal Impact Statement: The City Administrative Officer reports that the rent for Olvera Street Space C-4 will be adjusted from \$331 per month to \$920 per month, upon Commission and Council approval. Annual Consumer Price Index adjustments will be applied to the adjusted rent through 2021. The rent will also be re-assessed during the next market rate rent adjustment scheduled for 2021.

Community Impact Statement: None submitted.
