If the Neighborhood Council chooses to do so, the Neighborhood Council representative must provide the Commission with a copy of the CIS or rResolution sufficiently in advance for review, possible inclusion on the agenda, and posting on the Commission's website.Any information you can provide related to your agenda setting schedule is helpful to share with the NC.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Councils rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

DASH bus operator starting wages are near the bottom for transit agencies in the region: \$20.00 per hour, compared to \$24.37 on Los Angeles Metro and \$26.67 on Santa Monica Big Blue Bus, according to an LADOT report. This has created difficulties in hiring and retaining operators, who can use their skills and commercial driver's license at other agencies or in other sectors, for higher pay and/or

improved working conditions. As a result, DASH has faced shortages of operators that have hurt service supply and reliability. Ultimately, transit labor issues become transit rider issues. Failing to pay operators enough leads to canceled runs that strand travelers who depend on transit for their mobility. Degraded service pushes—or forces—people away from transit, thereby harming the City's climate, equity, and access goals. The work bus operators do is both vital and difficult. They deserve a raise in line with inflation and their peers at other agencies nearby. We suggest that their wages be at least commensurate with Los Angeles Metro operators and operators at other area systems and that they remain so over time, as wages on other agencies rise.
