On October 22, 2019, the Ad Hoc Committee on Comprehensive Job Creation Plan considered a  
report from the Chief Legislative Analyst (CLA), dated October 18, 2019, relative to the Citywide  
Bid Preference Programs and First Source Hiring Ordinance.

The Ad Hoc Committee on Comprehensive Job Creation Plan took the following actions:

- I. Adopt the recommendations of the CLA report, dated October 18, 2019, as amended  
below:

- Amend 1.c.i. to include the word "local" as follows:

...if the business submitting a proposal holds a Small **Local** Business Enterprise  
certification...

- Amend 2.a. regarding Transitional Job Opportunities Program as follows:

Effectuate the proposed changes to: the Transitional Job Opportunities Program,  
**including ensuring that Transitional Job Opportunities Programs are changed  
from being local to the state, to local to the County, to be consistent with all of  
the City's other local programs;** the Local Business Preference Program; and  
Small Business Program.

- Delete 2.b. and replace with:

Instruct the Bureau of Contract Administration and the Economic and Workforce  
Development Department to explore ways to automate the referral process.
