**MOTION**

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Susan Garcia v. City of Los Angeles, Los Angeles Superior Court Case No. BC531780 (this matter arises from Plaintiff's claims of retaliation and adverse employment actions), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to expend \$1,300,000 in settlement of the above-entitled matter.
2. AUTHORIZE the Controller to transfer \$1,300,000 from Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009792, Police Liability Payouts.
3. AUTHORIZE the City Attorney draw three separate demands from Fund No. 100/59, Account No. 009792, Police Liability Payouts as follows:
  - a. \$585,000 made payable to: McNicholas and McNicholas, LLP Client Account.
  - b. \$65,000 made payable to: Susan Garcia.
  - c. \$650,000 made payable to: MetLife Assignment Company, Inc. for the funding of a structured settlement.
4. AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.

This matter was recommended for approval by the Budget and Finance Committee (Krekorian – Koretz – Bonin: “Yes”; Blumenfield: “No”) at its meeting on June 4, 2018, in Closed Session as permitted by Government Code Section 54956.9(d)(1).
