MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Gayle Gluck v. Glazer Brothers Investments, LLC, et al, Los Angeles Superior Court Case No. BC554174 (this matter arises from a trip-and-fall accident that occurred on November 6, 2013 at 180 South La Brea Avenue, in the City of Los Angeles), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to expend up to \$850,000 in settlement of the above-entitled matter.
2. AUTHORIZE the Controller to transfer \$850,000 from the Liability Claims Fund No. 100/59, Account No. 009798, Miscellaneous Liability Payouts, to Fund No. 100/59, Account No. 009795, Public Works, Street Services Liability Payouts.
3. AUTHORIZE the City Attorney to draw a demand from Fund No. 100/59, Account No. 009795, Public Works, Street Services Liability Payouts, in the amount of \$850,000 and made payable to The Simon Law Group, LLP and Gayle Gluck.
4. AUTHORIZE the City Attorney, or designee, to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.
