SUBJECT:

Harbor Boulevard (Private) – Private Street Name Establishment - Rename Sampson Way (Private) between 8th Street (Private) and 22nd Street (Private) to Harbor Boulevard.

RECOMMENDATIONS:

- A. That the name of the private street Sampson Way (Private) from 8th Street (Private) to 22nd Street (Private), shown colored green on Exhibit “A”, be established as Harbor Boulevard (Private Street).
- B. That the Council, find that the name establishment is exempt from the California Environmental Quality Act of 1970, pursuant to Article III, Class 5(4) of the City’s Environmental Guidelines.
- C. That the City Clerk be instructed to transmit the following:


DISCUSSION:

Request: The petitioner, City of Los Angeles – Harbor Department, is requesting the City to change the existing name of the private street Sampson Way (Private) from 8th Street (Private) to 22nd Street (Private), as shown on Exhibit “A”, to Harbor Boulevard (Private).

The name establishment is required to designate this private STREET EXTENSION as Harbor Boulevard thus making Harbor Boulevard the main scenic route along the L.A. Waterfront. The portion of Harbor Boulevard northerly of this area will be dedicated as a public street under separate action in the near future.

Upon adoption of the Report by the City Council, the adjoining property owners and concerned agencies will be notified of the name establishment.
