Dear Councilmember Lee:

At its special meeting held May 29, 2020, the Ad Hoc on Comprehensive Job Creation Plan Committee considered a report from the Information Technology Agency (ITA), the Mayor's Office of Budget and Innovation (MOBI), and the Bureau of Contract Administration (BCA) dated May 27, 2020, relative to the Compete4LA's Proposed Regional Procurement Portal. At that time, the Ad Hoc Committee recommended that Council approve the recommendations of the joint report, as amended to incorporate the following:

1. Amend Recommendation No. 2 of the ITA-MOBI-BCA report to change the account and title of the fund from Economic Development Trust Fund to Account No. 22S983 Economic Development Projects-UDAG.
2. APPROVE a Public Works Trust Fund loan in an amount not to exceed \$579,000 for the Los Angeles Business Assistance Virtual Network (LABAVN) Replacement Project with a repayment schedule of three years, subject to the approval by the Board of Public Works, to be repaid either by LABAVN user fees, direct appropriation from the General Fund, or other identified sources.
3. AUTHORIZE and APPROPRIATE the transfer of loan proceeds from the Public Works Trust Fund No. 834/50 to ITA Fund No. 100/32, Account No. 3040 (Contractual Services).
4. INSTRUCT the Clerk to place on the earliest Council meeting in Fiscal Year (FY) 2020-21 the following:

INSTRUCT the Controller to transfer \$996,286 from FY 19-20 Fund No. 100/32

Account No. 3040, Contractual Services to FY 20-21 Fund No. 100/32 Account No. 3040, Contractual Services.

5. AUTHORIZE the City Administrative Officer (CAO) to make necessary technical changes to effectuate the intent of this action.
6. INSTRUCT the CAO and the Chief Legislative Analyst to seek Federal Emergency Management Agency or other sources of Federal or State COVID-19 emergency response sources of funding for this project.

Pursuant to the dual referral of this matter, the subject Council file is hereby transmitted to your Information, Technology, and General Services Committee for consideration.
