

HOUSING COMMITTEE REPORT relative to authorization to accept the 2019 Community Services Block Grant (CSBG) award.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the General Manager, Los Angeles Housing and Community Investment Department (HCIDLA), or designee, to:
 - a. Accept the 2019 CSBG award from the State of California, Department of Community Services and Development (CSD) on behalf of the City.
 - b. Execute and return to the CSD the signed CSBG Contract No. 19F-4022 with the required supporting documentation, subject to review by the City Attorney as to form and legality.
 - c. Execute any subsequent amendments to the CSBG Contract No. 19F-4022, subject to City Attorney review as to form and legality.
2. APPROVE the use of CSBG funds to operate the Family Source Center System for the period January 1, 2019 through December 31, 2019 as follows, subject to State appropriations of 2019 CSBG funds:

3. AUTHORIZE the Controller to:
 - a. Establish new account, 43R582 Family Source Centers- Non Profit and appropriate \$4,686,302 within the CSBG No. 428.
 - b. Establish a receivable from the CSD in the amount of \$6,576,134 within the CSBG Fund No. 428.
4. AUTHORIZE the General Manager HCIDLA, or designee, to prepare any Controller instructions needed to implement actions approved by the Council and Mayor on matters presented in or deriving from this transmittal, and/or to make necessary technical adjustments, subject to the approval of the City Administrative Officer (CAO); and, AUTHORIZE the Controller to implement the instructions.

Fiscal Impact Statement: The CAO reports that there is no impact to the General Fund. The recommended actions contained in the April 29, 2019 CAO report comply with City Financial Policies in that they provide for the acceptance of the 2019 Community Services Block Grant award, which will fund expenses incurred for the Family Source Center Program.

Community Impact Statement: None submitted.

Summary:

On May 8, 2019, your Committee considered April 29, 2019 CAO and April 1, 2019 HCIDLA reports relative to request for authority to accept the 2019 CSBG award. According to the CAO, the HCIDLA is requesting authority to accept the 2019 CSBG award in the amount of \$6,576,134 from the CSD to fund the Family Source Center Program. The HCIDLA is also requesting authority to execute the CSBG Contract No. 19F-4022 and subsequent amendments with CSD for the program year of January 1, 2019 through December 31, 2019. Finally, the HCIDLA is requesting approval of the proposed distribution of CSBG funds across program delivery and administrative costs. After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of the recommendations contained in the CAO report. This matter is now submitted to Council for its consideration.
