RE: COUNCIL FILE TRANSMITTAL

On August 20, 2019 the Energy, Climate Change, and Environmental Justice Committee considered Motion (Bonin – Harris-Dawson) relative to initiating a pilot program in Council District 11 to augment the new cleanup protocols proposed by the Bureau of Sanitation (BOS) including hygiene services that provide for attendant-supported restrooms, handwashing stations, and showers at some encampments in the district; and, identifying funding for two hygiene stations and their staffing costs for Council District 11 encampment services and cleanup pilot program, Council file 17-1121. After consideration, the Committee moved to approve the recommendations contained in the Motion as follows:

1. INSTRUCT the Chief Legislative Analyst (CLA) with the assistance of the Los Angeles Homeless Services Authority (LAHSA) and the BOS, in conjunction with Council District II staff, to initiate a pilot program in Council District 11 to augment the new cleanup protocols proposed by the BOS. In addition to the proactive services proposed by the BOS, such as the placement of receptacles and regular trash collection, and regularized public health and cleanup services that ensure clean streets and removal of bulky and hazardous materials, the Council District 11 pilot should include:

- a. Hygiene services that provide for attendant-supported restrooms, handwashing stations, and showers at some encampments in the district.
- b. Public health strategies supported by the Los Angeles County Department of Public Health (LACDPH).

2. INSTRUCT the City Administrative Officer (CAO) to work with the BOS to identify funding for the lease or purchase of at least two hygiene stations, inclusive of maintenance and full-time (24/7) attendant-staffing costs, for the Council District 11 encampment services and cleanup pilot program.
