Dear Council Member O'Farrell,

I recently wrote to you to support the conversion of St. Vincent Medical Center into housing and a support center for the homeless.

I similarly support using a city owned parking lot in the area of Echo Park park as a location for shelter and services for the homeless. I also support developing housing and a service site for the homeless on the city owned land that currently is used as a basketball court and for other recreational activities about which you recently received substantial and I believe unwarranted push back.

What I do NOT support is encampments of homeless around Echo Park lake. Rather, I believe that the ordinances forbidding sleeping/use of the park between 10:30 pm and 5:30 am should be enforced. I fully understand that the poor souls who are encamped there need a place to pitch their tents and roll out their sleeping bags but the city spent millions of dollars to restore that park and this is a city with far too little park land. Frankly, although many have not been deterred from using the park by virtue of the presence of so many homeless folks in the park, I have been, and I am sure I am not alone. (I also wonder why "my" park has so many homeless and the area around Silver Lake, where I now walk, has none.....) I therefore am also concerned that current efforts to have the restrooms open all night and to bring in portable showers while well-motivated really ratify the change of the area from park to a quasi permanent encampment (or as my husband calls it Hooverville — which shows our age) that is likely to attract even more homeless. I urge you to move forward with other solutions for the Echo Park lake homeless, and I will support them, as noted above, but please help give park users their full park back.

Hello Mitch,

I wanted you to know that I think repurposing the hospital is an excellent idea and I hope you can make it a reality.

Also - I'm having a huge problem. My dear friend Shirley is an 82 year old lady, who had a stroke last June and has been in and out of hospitals and nursing homes. One place in particular Lakeview Terrace, is a substandard nursing home, with a bad reputation and has been sued several times. Shirley was taken there from St Vincent hospital, against her will and without my knowledge ( I have been Shirley's caregiver for 5 years and have POA. ) She was discharged from the hospital, by a discharge planner named Cynthia, who knew I did not want Shirley to go there - but sent her there anyway.

Shirley, after being there for a few days was attacked by a known violent Mental patient, and when I intervened - I too was attacked. I called LAPD, The insurance company, the Ombudsman's office, and a bunch of other places , but I'm not being taken seriously.

The facility is trying to hush it up, but the trauma of this experience has affected Shirley so badly, I fear for her mental state as well as for her physical safety. She has been so badly abused, she has to be sedated to stop her from screaming.

She is now in another facility, but a few days ago, I found massive bruises around her neck and chest, and I am about to lose my mind...

The past few months have been so traumatic for us .. I need help..Please,





We have a family member who is battling mental health issues and is often homeless, we can see what a difference (safe) nights sleep and a good meal does for him. Yes 'issues' are still there but that extra edge of exhaustion induced paranoia & anxiety dissipate and he is nearly his 'old self'.

We are not experts but observation with our relative - yes, he needs treatment, and probably medication - but we realized that when people dealing with mental illness go on medication doctors stress that a 'routine' is very important. People need to take their meds at a certain time, avoid stress, get enough sleep, have healthy meals, see counselors all on a schedule. It's hard enough for homeless people to find a bathroom let alone 'stay on schedule.'

It seems that if folks (even if they have problems) get some kind of safe housing first it will be much easier for them to start, and then maintain a healthier lifestyle vs expecting somebody living on the street to bootstrap it up before they see any compassion or dignity.

This would be a much faster alternative than building shelters from the ground up - shift the funds from those already allocated for the homeless crisis into refurbishing the med center.
