Re: CF20-0102 Comprehensive Response Strategy

On Thursday, February 4, 2021 the Empowerment Congress North Area Neighborhood Development Council (NANDC) held our General Board Meeting. Agenda item VII(d) called for us to review and consider CF 20-0102. With a vote of 14-0-0, NANDC voted to support CF20-0102 which calls for the City Administrative Officer, with the assistance of the Los Angeles Homeless Services Authority and the Chief Legislative Analyst, to provide a verbal report on local initiatives that align with the Governor's Council of Regional Homeless Advisor's "Comprehensive Crisis Response Strategy" and to also report back on the necessary resources for establishing a Right to Housing framework within the City of Los Angeles.

Our support comes with two recommendations:

1. Any crisis housing created should be located along commercial corridors.
2. The conversion of vacant warehouses and office facilities should not override any existing local ordinances and historical laws that are in place to persevere the character of residential communities.

Please give these recommendations your utmost consideration.
