OFFICE OF FINANCE RECOMMENDATION TO APPROVE
REFUND CLAIM FILED BY FRED LOYA INSURANCE AGENCY INC**

The Office of Finance is recommending approval to pay the refund claim filed by Fred Loya Insurance Agency Inc for the amount of \$62,232.75. As determined by audit, the taxpayer erroneously paid, which resulted in the refund amount.

The Office of Finance recommends payment in the amount of \$62,232.75 plus accumulated interest. In compliance with Section 21.07(d) LAMC, interest shall be paid on the refund amount from the date of filing the claim until the payment issue date. Daily interest of \$6.14 shall continue to accrue on this claim until the date the refund is paid. Upon approval by the City Council, the demand will be drawn from Fund 100, Department 62, Revenue Source 3081 (Business Tax). Additional information regarding the refund claim is on the attachment.
