Summary: The East Hollywood Neighborhood Council is against the motion for CARE/CARE+ comprehensive cleanups to continue during the COVID-19 crisis. We strongly encourage the City Council to suspend these cleanups until the pandemic ends. We understand that the City Council is feeling pressure to provide sanitary perimeters for the A Bridge Home shelters. We appreciate the effort to install and maintain sanitation stations within the city and especially in areas that are highly populated by people experiencing homelessness. Due to our current health crisis, we believe that the comprehensive cleanups, and specifically requiring tents to come down during daytime hours, will put unhoused individuals at risk. By requiring unhoused individuals to move their tents during daytime hours, they face increased risk of contracting COVID-19, and/or face the possibility of violence from police. This is an unacceptable burden on individuals who are already vulnerable and in need of support from the city during this crisis. Additionally, we strongly suggest that council looks into ways to indefinitely suspend the provision of Los Angeles Municipal Code 56.11 that requires tents to come down during daytime hours within the A Bridge Home shelter Special Cleaning Zones. We welcome A Bridge Home shelters in our community, but do not want to cause further difficulties on people experiencing homelessness through the Special Cleaning Zones during the COVID-19 pandemic.
