Dear Budget and Finance Committee,

We are in the middle of a health pandemic with severe economic consequences. Over 50% of Angelenos are unemployed — and we can expect 42% lasting unemployment. Over 50% of this city is renters and if individuals are unemployed, they cannot pay rent. Before the pandemic, there were around 60k unhoused individuals; after evictions and economic insecurity due to COVID-19 and its fall out, we can expect thousands more. In this context, the Mayor is proposing an increase to LAPD, even though crime has fallen considerably during the past few months. LAPD has seen a rise in overtime which, more often than not, is paid out to officers harassing unhoused individuals, and Black, Indigenous, people of color. After declining to vote on this draconian proposal last week, City Council referred it back to the Budget and Finance Committee. Now, the Committee has decided not to meet, thereby shirking its duty and upholding the racist and white-supremacist structures that underlie both the proposal and City Council as a governing body. I am urging you to publicly support the People's Budget. The Mayor's disastrous proposal MUST be updated with the priorities of Angelenos. You need to Adopt a People's Budget which defunds the police. We need disinvestment from the police, and investment in community- and health-centered services.





## INTRODUCTION

The People's Budget LA Coalition has undertaken an urgent public process of participatory budgeting to solicit input of Angelenos on their priorities for the city and how they would like public resources to be spent. This project emerged rapidly and in direct response to the secretive, undemocratic process and draconian spending plan introduced by Mayor Eric Garcetti, and left unchallenged by City Council.

This report details our findings and presents a People's Budget alternative to the Mayor's proposed 2020-21 budget. **Our document and data both reveal a clear referendum: invest in universal needs (e.g., housing security, public health/health care, mental health and wellness, etc.) and divest from traditional forms of policing.**

Here's a summary of our methodology and results:


- More than 10,000 people were engaged in the drafting of the People's Budget. This includes 1,470 Angelenos who took our survey, 3,300 participants who engaged in our participatory budgeting process in real time on May 24, 2020 (via Zoom and Facebook Live), and 10,000 viewers who have watched the session after-the-fact.
- The top priorities for investment include housing, mental health and wellness, and public health and healthcare.
- The top priorities for divestment include parking enforcement, police and policing, and the City Attorney's Office.
- The People's Budget allocates just 5.7% of general funds to law enforcement and policing - just about one-tenth of the 54% given to the LAPD in the Mayor's proposed budget.
- The People's Budget allocates the largest amount of money to Universal Aid and Crisis Management (44.25%), followed by Built Environment (25.80%), then Reimagined Community Safety (24.22%), and finally Law Enforcement and Police (5.72%).

**We implore the Los Angeles City Council to take action and adopt a budget that aligns with the priorities of the people who they have been elected to represent.**

## SPENDING AREAS

### UNIVERSAL AID AND CRISIS MANAGEMENT

The Universal Aid and Crisis Management funding category supports the basic needs of Angelenos like housing, food, healthcare, economic assistance and emergency relief. Both survey participants and those participating in our participatory budgeting session emphasized universal aid and crisis management as their top priority, with a particular focus on housing.

This funding area includes funding for long-term housing, renter support and emergency housing, food assistance, support for those seeking work, support for small businesses, providing public health care, offering youth development programs and supporting youth centers, fighting the impacts of climate change and ensuring our city's environment is protected. This area also includes emergency preparedness for natural disasters like earthquakes and fire as well as the public health disasters.

## **THE BUILT ENVIRONMENT**

The Built Environment funding category focuses on our city's physical infrastructure like public transportation, libraries, parks, public works and the fire department. Based on our survey results, these are essential public goods for Angelenos.

## **REIMAGINED COMMUNITY SAFETY**

Participants were also committed to reimagining community safety and building and resourcing restorative justice practices that enable strong communities without law enforcement presence or intervention. The Reimagined Community Safety funding category supports a community-led safety model including investing in mental health and harm reduction approaches. Rather than funding police that bring violence and harm into our communities, Reimagined Community Safety invests in communities themselves to determine what they need and to offer them support in executing those programs.


Specific initiatives that could be included in this category are family counseling, restorative justice programs, reparations to victims and their families, community-led crisis response programs, gang prevention/intervention/recovery without police involvement, and domestic violence prevention/intervention/recovery without police involvement. This category also includes building stronger connections among neighbors through investing in community-led events.

## **LAW ENFORCEMENT**

The law enforcement category included all traditional approaches, including police, City Attorney, and traffic enforcement. Across all demographics of survey respondents, this was ranked as the lowest priority for spending.







## **PROCESS AND METHODOLOGY**

A survey was sent out by dozens of community organizations, with city-wide presence and representing neighborhoods throughout Los Angeles. The survey was also posted on more than 100 social media accounts and People's Budget LA's website. Responses were only accepted from residents of the City of Los Angeles who could identify their area of residence on an interactive map. Beyond the solicitation of survey responses, the coalition held a two-hour, online participatory budgeting session on Sunday, May 24, 2020 to share information about the city budgeting process and to gather public input. More than 10,000 people have viewed the session so far.

**1470 Angelenos responded to the survey and we are continuing to collect results  
3300 participants engaged in the participatory budgeting session in real time and an additional 10,000 viewers watched the session after-the-fact.**

Survey responses included constituents from all 15 council districts. The survey data is available for exploration in a Tableau dashboard (linked at [PeoplesBudgetLA.com](https://PeoplesBudgetLA.com))

## **ADOPT A PEOPLE'S BUDGET**

We believe that the government should be responsive to the needs, priorities, and demands of the people. There is clearly a wide chasm between the budget proposed by the Mayor (and directly or indirectly endorsed by the City Council) and the one envisioned by Los Angeles residents. The City Charter enables Council to pass or revise the Mayor's budget proposal or submit a new budget for implementation. In a democracy, the Council should listen to the will of the people and pass a People's Budget that centers the priorities that Angelenos have listed as central to them by June 1, 2020.

Dear Councilmembers,

I'm writing to express my outrage over the 2020-21 city budget, adopted yesterday, which increases LAPD officer pay by \$144 million while slashing city investments in vital public services, including housing, jobs, infrastructure, mental health care, after-school programs, and gang intervention.

Under this current budget, the LAPD is slated to receive well over half of the City's total budget or 54 percent, while some 16,000 civilian city workers are furloughed and a quarter of Angelinos are unemployed, with even more facing housing and food insecurity during this time of unprecedented health and economic crisis.

Balancing itself on the backs of our city's most vulnerable, this budget was morally irresponsible when Mayor Garcetti proposed it over a month ago. After the events of the past week—namely, the large-scale mobilization of the city's police force with its full arsenal of military-grade riot gear against largely peaceful protesters calling for an end to police brutality against black people and other minorities—it is downright unconscionable. This LAPD deserves a dramatic decrease in funding, along with radical civilian oversight and accountability—not a raise and bonuses to officers with college degrees.

I understand that the lopsided City budget allocations that cut funding to all programs except fire and police are a product of agreements reached between the City and the Los Angeles Police Protective League to raise officer pay two times in the coming fiscal year. Those raises, while always of dubious merit, are entirely inappropriate now, with City revenues disastrously low in the wake of the COVID-19 pandemic that has left even more Angelinos reliant on public services, to say nothing of the aggressive (and largely ineffective) policing of the last week. If LAPD officers simply received the same pay they received last year, two-thirds of proposed cuts to other essential services could be avoided. The City must withdraw these scheduled pay increases, even if it means reopening negotiations with the police officers union.

This budget does not reflect my values, or the values of my community, nor will it make our city safer. But there's still time to get this right. In the month that remains before the budget process concludes and this disastrous budget goes into effect, it is incumbent on you and the rest of the Budget and Finance Committee to draft and adopt sweeping amendments that reallocate funds away from law enforcement and into those programs that support citizens. We are counting on you, our elected officials, to create a compassionate, equitable budget that truly serves our city's needs.

I am Klaus Steden, and I am writing to express my concern in regards to the current allocation of the City of Los Angeles' budget — in 2019-2020, more than 52% of the City's general fund was allocated to police. That amount is set to go up in 2020-2021.

In light of the many deaths of African Americans at the hands of police across the United States, I am concerned and disheartened that my tax dollars are being used to fund a service that continues to victimize members of this community.

Accurate data on officer-involved shootings is difficult to come by, but according to an investigative report from KPCC, on-duty LAPD officers shot at least 375 people between 2010 and 2014 — 24% of them were Black, though African Americans make up only 8% of the L.A. population. Of 279 people who were shot for "ignoring officer commands," 120 "showed signs of mental illness or impairment from drugs or alcohol." Most officers receive just six to 10 hours of training on how to deal with individuals with mental illnesses.

I would like to see a re-evaluation of the budget currently allocated to the Los Angeles Police Department. I would like to see this large portion of my tax dollars reallocated into social services, mental health programs, healthcare, education, jobs, and city infrastructure.

I would like to see any budget that is allocated to the Los Angeles Police Department made transparent and with a focus on harm reduction.

A coalition of advocacy groups in Los Angeles has put together a comprehensive People's Budget with input from thousands of Angelenos. The budget outlines spending priorities as identified by members of the community who are served by — and fund — the City's budget. I'm writing to express my outrage over the 2020-21 city budget, adopted June 1st, which increases LAPD officer pay by \$144 million while slashing city investments in vital public services, including housing, jobs, infrastructure, mental health care, after-school programs, and gang intervention.

Under this current budget, the LAPD is slated to receive well over half of the City's total budget or 54 percent, while some 16,000 civilian city workers are furloughed and a quarter of Angelinos are unemployed, with even more facing housing and food insecurity during this time of unprecedented health and economic crisis.

Balancing itself on the backs of our city's most vulnerable, this budget was morally irresponsible when Mayor Garcetti proposed it over a month ago. After the events of the past week—namely, the large-scale mobilization of the city's police force with its full arsenal of military-grade riot gear against largely peaceful protesters calling for an end to police brutality against black people and other minorities—it is downright unconscionable. This LAPD deserves a dramatic decrease in funding, along with radical civilian oversight and accountability—not a raise and bonuses to officers with college degrees.

I understand that the lopsided City budget allocations that cut funding to all programs except fire and police are a product of agreements reached between the City and the Los Angeles Police Protective League to raise officer pay two times in the coming fiscal year. Those raises, while always of dubious merit, are entirely inappropriate now, with City revenues disastrously low in the wake of the COVID-19 pandemic that has left even more Angelinos reliant on public services, to say nothing of the aggressive (and largely ineffective) policing of the last week. If LAPD officers simply received the same pay they received last year, two-thirds of proposed cuts to other essential services could be avoided. The City must withdraw these scheduled pay increases, even if it means reopening negotiations with the police officers union.

This budget does not reflect my values, or the values of my community, nor will it make our city safer. But there's still time to get this right. In the month that remains before the budget process concludes and this disastrous budget goes into effect, it is incumbent on you and the rest of the Budget and Finance Committee to draft and adopt sweeping amendments that reallocate funds away from law enforcement and into those programs that support citizens.
