
Subject: RESOLUTION NO. 19-9578 – PROPOSED APPROVAL OF PERMIT NO. 943 WITH  
CRIMSON CALIFORNIA PIPELINE, L.P., A CALIFORNIA LIMITED PARTNERSHIP

Pursuant to Section 606 of the City Charter, enclosed for your approval is Resolution No. 19-9578 authorizing proposed Permit No. 943 with Crimson California Pipeline, L.P. a California Limited Partnership; which was approved at the December 19, 2019 meeting of the Board of Harbor Commissioners. Proposed Permit No. 943 is for a term of 20 years to occupy 2,259 square feet of subsurface pipeline right-of-way in East Wilmington. Currently, these premises are occupied on holdover under Permit No. 736 and generate \$2,942 in annual rental revenue. Under the proposed Permit No. 943, annual rental revenue would increase by \$1,382 to \$4,324 per year, subject to annual increases based on the Consumer Price Index. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

1. ADOPT the determination by the Board of Harbor Commissioners that the proposed action is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with Article III, Class 1(18) of the Los Angeles City CEQA Guidelines;
2. APPROVE Harbor Department Resolution No. 19-9578 authorizing proposed Permit No. 943 with Crimson California Pipeline, L.P. a California Limited Partnership; and
3. Return to the Board of Harbor Commissioners for further processing.
