

AD HOC REDISTRICTING COMMITTEE REPORT relative to Redistricting Proposals for the Los Angeles City Council.

Recommendations for Council action:

1. ADOPT the Chief Legislative Analyst (CLA) Hybrid draft map as amended by the Ad Hoc Redistricting Committee, as the City Council's Draft Map for Council district boundaries:
 - a. Restore Stonehurst to Council District 7.
 - b. Incorporate fully amending motion 46T.
 - c. Move eastern border of Reseda to Lindley - flexible to include investment projects on Sherman Way.
 - d. Include amending motion 46V.
 - e. Increase Elysian Park in Council District 13 to include expanding from the existing line of Stadium Way from Riverside to include Academy road to Angels Point, and Stadium Way (Ave of the Palms) to Scott Avenue.
 - f. Move the area bounded by Franklin on the north, La Brea on the east, Sunset on the south, and Vista on the west from Council District to Council District 4; and, SPLIT a census block south of Sunset to move Durant Library (between Formosa and Detroit) from Council District 13 to Council District 4.
 - g. Move everything south of the Tujunga wash, west of Colfax from Council District 2 to Council District 4.
2. REFER the Los Angeles City Council Redistricting Commission recommendations concerning future redistricting processes to the Rules and Elections Committee for further consideration.
3. INSTRUCT the Bureau of Engineering to prepare the metes and bounds for the adopted map and submit them to the City Attorney to support the necessary ordinance no later than November 29, 2021.
4. REQUEST the City Attorney to prepare and transmit the necessary ordinance no later than November 30, 2021.

At its special meeting held on November 5, 2021, the Ad Hoc Redistricting Committee considered a CLA report relative to the Redistricting Proposals for the Los Angeles City Council.

The Committee Chair provided an overview of the process of the Ad Hoc Redistricting Committee meeting, including a presentation by the CLA, opportunity for questions, clarifications, and amendments, and two opportunities for public comment. Representatives from the Office of the CLA provided an overview and responded to questions posed by the Committee. Councilmembers Martinez, De Leon, Blumenfield, Price and O'Farrell all introduced amending motions, duly seconded, to the CLA report which were all approved by the Committee. After providing a second opportunity for public comment, Councilmember Raman introduced two additional amending motions which were approved by the Committee.

After providing two opportunities for public comment, the Committee recommended that the Council approve the recommendations in the CLA report, as amended, as stated above. This matter is now forwarded to the Council for its consideration.
