Dear Honorable Members of Los Angeles City Council:

The Granada Hills North Neighborhood Council agrees Diversity, Equity, and Inclusion Training and Anti-Bias Training is important training for all elected and appointed officials of the City of Los Angeles.

All officials for the City of Los Angeles, whether elected, appointed, paid or unpaid, must work with officials and members of the community, including but not limited to persons who are all races, ages, gender identities, religions, physical limitations, disabilities, social status, and residential status. Mandatory training should be required for all officials in order to work with all people.

GHNNC requests an amendment to Council File 20-0990 requiring mandatory training for Diversity, Equity, and Inclusion and Anti-Bias Training only for Neighborhood Council board members. The training should be mandatory for all elected officials, regardless of the office or position held. This includes all politically appointed officials, commissioners, and non-union management and Neighborhood Council members for the City of Los Angeles.
