In February 2021, the City Council voted unanimously in favor of the proposed Ordinance and it is now being drafted by the City Attorney's office. However, in order to be passed into law, the official Ordinance posted by the City Attorney will need to be voted on again by L.A. City Council Members. Take action now!
