The cruelty and killing of animals at rodeos I have captured is often missed by the crowd in the stands. As a result, many rodeos now ban the cameras I use because they do not want the public to know about the routine cruelty and killing of animals at rodeos. The Humane Rules of the rodeo are only for public relation purposes and are not enforced. Animal injuries and deaths are falsified. In real sports - baseball, football, etc., participant injuries are publicized and the victims provided immediate medical care and support during their recovery. Injured animals are shipped off to slaughter, because to humanely euthanize them cost money and would taint the meat for human consumption. Children are being taught that violence to animals is encouraged and glorified. The FBI has proven that violence to animals leads to violence to humans.
