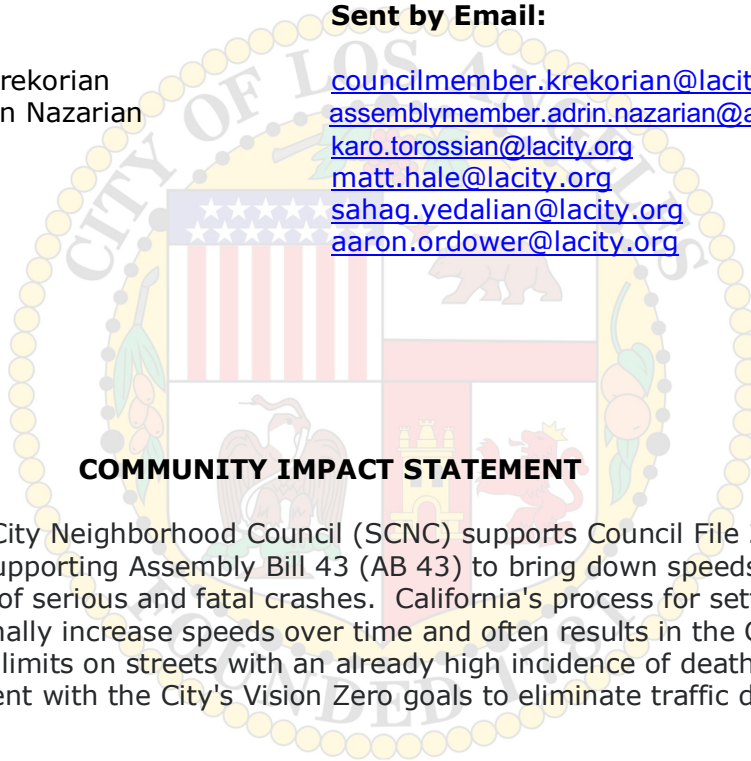

**COMMUNITY IMPACT STATEMENT**

The Board of the Studio City Neighborhood Council (SCNC) supports Council File 21-0002-S134, a City Council Resolution supporting Assembly Bill 43 (AB 43) to bring down speeds on streets where there are a high number of serious and fatal crashes. California's process for setting speed limits has proven to unintentionally increase speeds over time and often results in the City being mandated to raise speed limits on streets with an already high incidence of death and serious injury, which is inconsistent with the City's Vision Zero goals to eliminate traffic deaths.
