RE: TRANSMITTAL FOR COUNCIL FILE NO. 21-0329

On March 3, 2022, the Energy, Climate Change, Environmental Justice, and River (ECCEJR) Committee considered the February 24, 2022 City Administrative Officer (CAO) report relative to the funding for the Los Angeles Homeless Services Authority's Homeless Engagement Teams. After providing an opportunity for public comment, the ECCEJR Committee approved the recommendations as amended to replace the recommendations on the first page of the CAO report as follows:

1. APPROVE the transfer of up to \$1,307,572 from the Unappropriated Balance, Fund No. 100/58, Account No. 580326 HETs - Comprehensive Cleaning and Rapid Engagement Teams to the General City Purposes, Fund No. 100/56, Account No. 000826 Homeless Shelter Program, and appropriate therefrom to the LAHD Fund No. 10A/43, Account No. 43V687 HET Homeless Outreach and Partnership Endeavor to fund six additional months of the LAHSA HETs - Comprehensive Cleaning and Rapid Engagement Teams for Fiscal Year 2021-22.
2. INSTRUCT the General Manager, LAHD, or designee, to amend the City's 2021-22 General Fund Contract with LAHSA to reflect the funding allocation in the up to amount of \$2,615,144 for twelve months of salaries and expenses for LAHSA HET Comprehensive Cleaning and Rapid Engagement Teams for Fiscal Year 2021- 22.

Pursuant to the multiple referral of this matter, the subject Council File is hereby transmitted to the Homelessness and Poverty Committee for consideration. This matter awaits consideration by the Homelessness and Poverty Committee.
