

ADMINISTRATIVE AND CATEGORICAL EXEMPTIONS and TRADE, TRAVEL, AND TOURISM COMMITTEE REPORT relative to a Los Angeles World Airports (LAWA) contract with EMS Bruel & Kjaer, Inc., d.b.a. Envirosuite, Inc.

Recommendations for Council action:

1. ADOPT the determination by the Board of Airport Commissioners (BOAC) that the proposed action is administratively and categorically exempt under the California Environmental Quality Act (CEQA) in accordance with Article II, Section 2.f and Article III, Class 2 (3) of the Los Angeles City CEQA Guidelines.
2. APPROVE the LAWA contract with EMS Bruel & Kjaer, Inc., d.b.a. Envirosuite, Inc., for the replacement of the existing Noise and Operations Monitoring System at Los Angeles International (LAX) and Van Nuys Airport, and ongoing system maintenance services, for a total cost not to exceed \$7,725,732, and for a term of five years with two three-year extension options.
3. CONCUR with the action taken by the BOAC on April 1, 2021, by Resolution No. 27237, authorizing the Chief Executive Officer, LAWA, to execute the contract with EMS Bruel & Kjaer, Inc., d.b.a. Envirosuite, Inc.

SUMMARY

In a report to BOAC dated April 1, 2021, LAWA requests authority to execute a contract with EMS Briel & Kjr, Inc., to replace the existing Noise and Operations Monitoring System at LAX and Van Nuys Airport. The existing system has reached its end-of-life cycle and will require replacement to ensure a proper functioning. Staff uses this system to measure aircraft noise levels, monitor and enforce noise abatement programs, investigate and respond to noise comments, and produce noise reports and contour maps, in accordance with California Code of Regulations, Title 21, Airport Noise Standards requirements. Following the issuance and evaluation of a Request for Proposals in 2020, LAWA selected EMS Briel & Kjr, Inc., for the contact award.

On April 1, 2021, BOAC approved the LAWA contract with EMS Briiel & Kjr, Inc.

At its meeting held May 11, 2021, the Trade, Travel, and Tourism Committee recommended that Council approve the proposed contract award, as recommended by BOAC.
