The Silver Lake Neighborhood council strongly SUPPORTS Council File 21-0533.
The Silver Lake Neighborhood Council supports the motion and urges no new gas, diesel, and fossil fuel stations be permitted in the city.

Gas stations contribute to air and soil pollution and have been proven to have harmful health effects to surrounding communities. We should be moving away from gas by refocusing our collective efforts towards clean transportation in accordance with City, State, and National climate goals in mind, rather than adding to the already-existing 600 gas stations across L.A. County.

Furthermore, Los Angeles is facing an exhaustive housing crisis and the creation of new stations would disproportionately affect already hard-hit, low-income communities of color. Fortunately, this motion encourages retooling already existing gas stations with electric vehicle chargers and would continue to allow permits to non-fuel facilities like convenience stores and car washes.
