



RESOLUTION NO. 27259

WHEREAS, on recommendation of Management, there was presented for approval, First Amendment to Contract DA-5278 with ID Systems & Supplies Co. to extend the term through June 30, 2022, with a one (1)-year extension option, covering provision of security badge cards for the security badge program of Los Angeles World Airports; and

WHEREAS, in April 2018, by Resolution 26472, the Board of Airport Commissioners approved award of a three (3)-year contract to ID Systems & Supplies Co. to supply and deliver security badge cards to Los Angeles World Airports (LAWA), for amount not to exceed \$1,995,000; and

WHEREAS, LAWA Airport Police Division, Security Credentials Section, is required under Code of Federal Regulations Title 49 Part 1542 to administer a comprehensive security badge program for all airport workers that require access to secure or restricted areas. The First Amendment would allow for purchase of blank identification cards to produce Secure Identification Display Area badges for airport and airline employees who need new badges or need to be rebadged; and

WHEREAS, currently, there are over 55,000 badged employees and 30,000 badges that need to be replaced immediately and over the next twelve (12) months, and therefore, there is an immediate need for additional blank identification cards. The contract extension will allow the Security Credentials Section to procure a sufficient amount of blank identification cards to service LAWA's current badging needs, as well as the estimated need for large scale capital improvement projects. Due to the low number of badges issued during the pandemic, additional appropriations for funding is not needed; and

WHEREAS, funds for this item have been requested in Fiscal Year 2021-2022 LAWA Operating Budget in LAX Cost Center 1160022 – Security Credentials Section, Commitment Item 522 – Security Badge Supplies. Funding for subsequent years will be requested as part of the annual budget process; and

WHEREAS, this item, as a continuing administrative, maintenance and personnel-related activity, is exempt from California Environmental Quality Act (CEQA) requirements pursuant to Article II, Section 2.f. of the Los Angeles City CEQA Guidelines; and

WHEREAS, ID Systems & Supplies Co. is statutorily exempt from the provisions of the Living Wage/Service Contractor Worker Retention Ordinances; and

WHEREAS, ID Systems & Supplies Co. will comply with the provisions of the Affirmative Action Program; and

WHEREAS, ID Systems & Supplies Co. has been assigned Business Tax Registration Certificate 0000728234-0001-3; and

WHEREAS, ID Systems & Supplies Co. will comply with the provisions of the Child Support Obligations Ordinance; and

WHEREAS, ID Systems & Supplies Co. has submitted the Contractor Responsibility Program Questionnaire and Pledge of Compliance, and will comply with the provisions of said program; and



WHEREAS, ID Systems & Supplies Co. must be determined by Public Works, Office of Contract Compliance, to be in full compliance with the provisions of the Equal Benefits Ordinance prior to execution of the contract; and

WHEREAS, ID Systems & Supplies Co. is required to comply with the provisions of the First Source Hiring Program for all non-trade Los Angeles International Airport jobs; and

WHEREAS, ID Systems & Supplies Co. has submitted the Bidder Contributions CEC Form 55, and will comply with its provisions; and

WHEREAS, ID Systems & Supplies Co. has submitted the Municipal Lobbying Ordinance CEC Form 50 and will comply with its provisions; and

WHEREAS, actions taken on this item by the Board of Airport Commissioners will become final pursuant to the provisions of Los Angeles City Charter Section 373;

NOW, THEREFORE, BE IT RESOLVED that the Board of Airport Commissioners adopted the Staff Report; determined that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II, Section 2.f. of the Los Angeles City CEQA Guidelines; approved the First Amendment to Contract DA-5278 with ID Systems & Supplies Co. to extend the term through June 30, 2022, with a one (1)-year extension option, covering provision of security badge cards for the security badge program of Los Angeles World Airports; certified that the First Amendment is entered into in accordance with City Charter Section 371(e)(10) and Los Angeles Administrative Code Section 10.15(a)(10); and authorized the Chief Executive Officer to execute said First Amendment to Contract DA-5278 with ID Systems & Supplies Co. after approval as to form by the City Attorney and approval by the Los Angeles City Council.
