On August 19, 2021 in a Brown Act compliant meeting, the Lincoln Heights Neighborhood Council considered the following resolution regarding Motion CF 21-0690 *EL Recreo Room/ the intent to transfer existing alcohol license submitted by Gypsy Sanchez on behalf of Anna Maritza Johnson*. The stakeholders and elected officials have come to the following conclusions listed below:

WHEREAS, On June 11, 2021 applicant submitted application for the Determination of Public Convenience or Necessity relative to the sale of alcoholic beverages for El Recreo Room, located at 506 West Avenue 28.
