Skid Row Community Vaccination Outreach Grant by the Mayor's Fund for Los Angeles and the Los Angeles Parks Foundation for Vaccination Outreach at San Julian and Gladys Parks; Acceptance of Grant Funds

Recommendation for Council Action:

The Board of Recreation and Park Commissioners (Board) respectfully requests City Council and Mayor approval for the Department of Recreation and Parks (RAP) to (i) accept the "Skid Row Community Vaccination Outreach" grant through the Mayor's Fund for Los Angeles (MFLA) and the Los Angeles Parks Foundation (LAPF) in the amount of Thirteen Thousand Two Hundred Dollars (\$13,200) in support of vaccination outreach at San Julian Park and Gladys Park in the Skid Row area of the City (Grant), (ii) Authorize RAP's General Manager or designee to accept and receive the awarded Grant funds, as further detailed in attached Report No. 21-150.

Background:

MFLA is a nonprofit public benefit organization that is dedicated to improving life for Los Angeles residents through economic prosperity, community resiliency, civic improvements, and government efficiency. MFLA selects organizations that are committed to engaging public and private resources, demonstrates collaboration, seeks innovative solutions, and yields measurable and transformational impact.

Fiscal Impact Statement:

Acceptance of this Grant will have no impact on RAP's General Fund, except for unknown savings, as Grant funds may offset some expenditures. LAPF remains the primary grantee of these funds from MFLA and RAP is the subgrantee of these funds from LAPF.
