Irma rallied 200+ Active Older Adult Students in the San Fernando Valley and North/East L.A. while working with educators and students throughout the City of Los Angeles; together gathering 1000s of signatures on petitions, writing hundreds of letters, and making 100s of phone calls to Save Adult Education, Older Adult Education and Parent Education. These efforts contributed to the passing of AB189 and PROP 30 which brought additional Funding.

(2012) Irma and her students were invited by **Councilmember Eric Garcetti** to stand by his side when he spoke at the LAUSD Board of Education Meeting in support of Saving LAUSD Adult Education. On another day, Irma and student leaders testified before the LAUSD Board of Education with approx. 50 Active Older Adult Students attending as part of a citywide campaign to Save Adult Ed within LAUSD. (see link: <http://saveadulthood.wordpress.com/2012/06/01/older-adults-speak-out-in-support-of-adult-education-laUSD-board-meeting/>)

In opposition to the continued cuts and proposed elimination of Older Adult Education and Parent Education, in 2013, Irma founded the CA Coalition to Save Older Adult Education in collaboration with Family Literacy/Parent Education. She and her key members met with the Governor's Office, State Board of Education, Department of Education, legislators and their staff as well as testified in Sacramento before various Assembly and Senate Committees on K-12 and Higher Education; and again before the LAUSD Board of Education with over 100 Active Senior Citizens and supporters in attendance.

June 2015, Governor Jerry Brown approved eligibility for funding of Older Adult Ed and Parent Ed as well as created two additional categories to serve Older Adults, however, leaving the final decision to local school districts. Some districts maintained or reinstated these programs, however, LAUSD has not. Our Coalition was victorious in gaining additional funds for Older Adult Ed and leaving the door open for future advocacy efforts to assure that low income Active Senior Citizens have access to these vital services.
