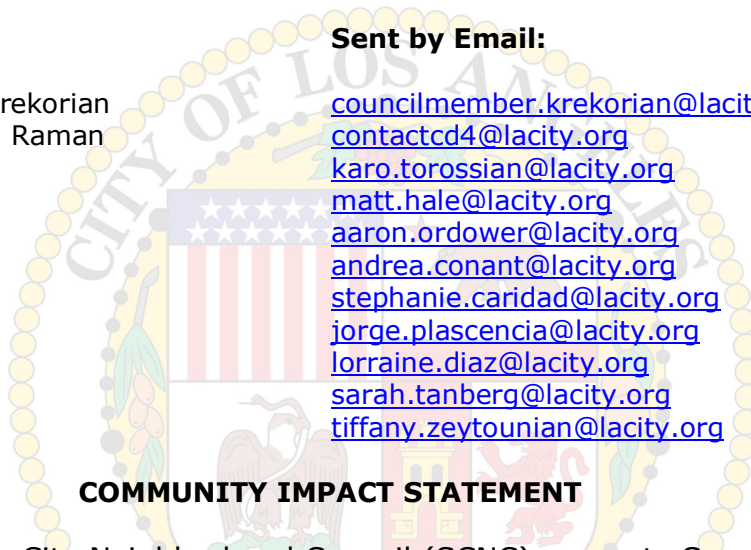

The Board of the Studio City Neighborhood Council (SCNC) supports Council File: 21-1415 Naloxone Training and Distribution / Street-Based Services / Shelter Sites / Drug Overdose / People Experiencing Homelessness / Los Angeles Homeless Services Authority. The motion has three parts. It would (1) direct LAHSA to identify and report all agency staff and contracted providers who have received naloxone training and distribution and identify opportunities to expand these services; (2) direct the Chief Legislative Officer to do the same for city departments; and (3) direct the Chief Legislative Officer to identify any current and future 2021-2025 years County, State, and Federal legislation for the City Council to consider taking an official position that would address areas around funding and access to drug treatment, medical training, and Recovery Bridge Housing.
