**RECOMMENDATIONS FOR CITY COUNCIL:**

**Board of Airport  
Commissioners**

1. Adopt the determination by said Board that this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Article II, Section 2.f. of the Los Angeles City CEQA Guidelines; and
2. Further adopt the determination by said Board that no further environmental documentation is required for the Runway 6L-24R Exits, Taxiway D and E Easterly Extension, Taxiway C Easterly Extension, and Taxiway D Westerly Extension between Taxiway AA and Taxiway E17 Improvements, which were fully evaluated in the Final Environmental Impact Report for the Los Angeles International Airport Airfield and Terminal Modernization Project that was certified by the Board of Airport Commissioners on October 7, 2021, in compliance with CEQA; and
3. Further adopt the determination by said Board that the Runway 6R-24L Rehabilitation and Runway 6L-24R Rehabilitation Projects are exempt from CEQA pursuant to Article III, Section 1.a.3 of the Los Angeles City CEQA Guidelines and Section 15301 of the State CEQA Guidelines; and
4. Approve Award of seven (7)-year Contract to HNTB Corporation, covering professional engineering design and construction administration services for airfield improvement projects at Los Angeles International Airport, for cost not to exceed \$34,700,000; and
5. Concur with said Board's action on December 16, 2021, by Resolution 27408, authorizing the Chief Executive Officer, or designee, of Los Angeles World Airports to execute said Contract.
