<b>ENTITLEMENTS FOR CITY COUNCIL CONSIDERATION</b>		
<p>This item is to approve the Sustainable Communities Environmental Assessment (SCEA) for the future consideration of the development of the project identified as Planning Case Numbers: <b>CPC-2018-2853-TDR-MCUP-CU-DD-SPR</b> and <b>VTT-82178</b>. Public Resources Code (PRC) Section 21155.2 requires the City Council to adopt findings and the SCEA prior to project approval if the City Council is not the decision-maker on the project approvals.</p>		

Planning has reviewed and circulated the SCEA as required by law and is now recommending that the City Council consider and adopt the SCEA (ENV-2018-2857-SCEA).

The SCEA (ENV-2018-2857-SCEA) and Errata dated March 2022 determined that all potentially significant environmental impacts can be mitigated to less than significant levels. Mitigation measures were adopted for the following impact area: Geology and Soils (Paleontological Resources) and Noise. The Project site is not included on the lists enumerated under Gov. Code Section 65962.5. Pursuant to Section 21155.2 of the PRC, this SCEA: 1) incorporates all feasible mitigation measures, performance standards, or criteria set forth in the prior applicable environmental impact reports, including the Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS) prepared by the Southern California Association of Governments (SCAG), and adopted in findings made pursuant to Section 21081; and 2) contains mitigation that either avoids or mitigates to a level of insignificance all potentially significant or significant effects of the Project required to be identified in the initial study prepared for the Project.

FIND, pursuant to Public Resources Code (PRC), Section 21155.2, after consideration of the whole of the administrative record, including the SB 375 Sustainable Communities Environmental Assessment, No. ENV-2018-2857-SCEA ("SCEA"), the Errata dated March 2022, and all comments received, after imposition of all mitigation measures, there is no substantial evidence that the project will have a significant effect on the environment;

FIND that the City Council held a hearing on and adopted the SCEA on [redacted] pursuant to PRC Section 21155.2(b)(6);
