The Board of the Studio City Neighborhood Council (SCNC) supports Council File 22-0415: Title, Serious Violent Crimes / Public Transit System / Safety / Armed and Unarmed Response Models. Given the recent spike in violent crimes in and around transit, as well as the changing perceptions of the need for alternative approaches to public safety on transit systems, it is imperative that the

Los Angeles Department of Transportation and the Los Angeles Police Department be directed to report back on how to improve safety in all City transit systems and station stops as it relates to serious and violent crime. Additionally, the Los Angeles County Metropolitan Transit Authority (Metro) is requested to report both past and upcoming efforts to curtail the issue of violent crimes on trains, buses, and transportation stops, including an analysis of armed and unarmed response models.
