



That the Board REQUEST the Mayor and City Council to AUTHORIZE the Controller to appropriate \$14,855.90 to the Police Department Trust Fund No. 885/Appropriation Account to be determined, Department No. 70 for the Dockless Scooter Outreach program, and therefore, REIMBURSE to Fund No. 100, Department No. 70, account number and amount as follows, and authorize the Police Department to make any necessary technical adjustments as needed:

DISCUSSION

Dockless Scooters were introduced into the community with minimal education to the ridership on its lawful operations in the City of Los Angeles. As a result, several unforeseen traffic safety problems and community complaints have risen. The problems and complaints focus on the dangerous riding behaviors of scooter operators on the roadways, such as riding while intoxicated, riding on sidewalks, being unlicensed or underage, and committing other traffic infractions that often result in traffic collisions.

This grant will fund the implementation of a traffic safety campaign focused on educating Dockless Scooter operators, as opposed to taking enforcement action. The goals of the program are to change the driving behaviors of scooter operators by educating them on the California Vehicle Code and to reduce the number of scooter-related traffic collisions. The Department will conduct a minimum of nine traffic safety campaigns, which will be staffed by one sergeant and one police officer who will be compensated on a cash overtime basis through the donation.

The Los Angeles Police Foundation is an independent, not-for-profit organization that provides critical resources and vital support to the Los Angeles Police Department (LAPD). From essential equipment and state-of-the-art technology to specialized training and innovative programs that would otherwise be unfunded, the Foundation provides funding that directly improves public safety, impacts officer readiness, and enhances the quality of life of all members of the community. Provide a brief description and purpose of the request for the expenditure from this Division Restricted Account:

The Los Angeles Police Department will conduct a traffic safety campaign focused on educating Dockless Scooter operators, opposed to taking enforcement action. The campaign will involve one on one interaction between officers and scooter operators. The interaction will commence through consensual encounters.

Upon meeting with the scooter operator, Department personnel will discuss traffic safety issues and statues of the California Vehicle Code related to scooter operations. This campaign is an extension of a program funded by the Los Angeles Police Foundation (LAPF) in 2019 via the Dockless Scooter Outreach Grant No. 2019-061.

The Department will conduct a minimum of nine traffic safety campaigns, which will be staffed by one sergeant and one police officer who will be compensated on a cash overtime basis. The following is a breakdown of the overtime costs for the campaigns:

1 Sergeant (per Hour)	\$105
1 Police Officer (per Hour)	\$95
Cost per Hour	\$200
Hours per Detail	X8
Cost per Detail	\$1,600
Number of Details	X9
Total	\$14,400.00

Funding for this campaign in the amount of \$14,855.90 will be transferred from the Educational Pole Banner Grant, which was funded by the Police Foundation in 2020. Personnel from Traffic Group contacted the LAPF and the staff was able to obtain approval from the grantor to use the funds for Dockless Scooter Outreach Grant. The

NAME OF REQUEST: DOCKLESS SCOOTER OUTREACH GRANT

It is requested that Traffic Group (TRFG) be approved to accept the Dockless Scooter Outreach Grant in the amount of \$14,855.90. Approval of this grant benefits the Department as follows:

Dockless Scooters were introduced into the community with minimal education to the ridership on its lawful operations in the City of Los Angeles. As a result, several unforeseen traffic safety problems and community complaints have risen. The problems and complaints have focused on the dangerous riding behaviors of scooter operators on the roadways, such as riding while intoxicated, riding on sidewalks, being unlicensed or underage, and committing other traffic infractions that have resulted in traffic collisions.

Acceptance of the grant will enable the Department to provide much needed education to scooter operators in the community. The goals of the grant are to change the driving behaviors of scooter operators by educating them on the California Vehicle Code and to reduce the number of scooter related traffic collisions. The grant will allow the Department to conduct nine traffic safety campaigns that will be staffed by one sergeant and one police officer. The traffic safety campaign will involve one on one interaction between the officers and the scooter operators. The campaign's primary focus will be on educating scooter operators opposed to taking enforcement actions. Personnel assigned to the campaign will be compensated on a cash overtime basis.


The funds will be transferred from the Educational Pole Banner Grant, which was awarded to the Department by the Los Angeles Police Foundation (LAPF) in 2020. The LAPF staff was able to obtain approval from the grantor to use the funds from the Educational Pole Banner Grant for the Dockless Scooter Outreach Grant.


