The Los Angeles Fire Department Foundation (LAFDF) has graciously donated psychology services to the Los Angeles Fire Department (LAFD). The psychology services will be supplemental services from the LAFD's Fire Psychologist. The value of this donation is estimated at \$85,000.00.

RECOMMENDATIONS

2. Request the Commission Executive Assistant to transmit this report to the Mayor's Office in accordance with Executive Directive No. 3 and to City Council in accordance with the Los Angeles Administrative Code, Ordinance 15514, Article 12, Section 5.111.4 , for consideration and approval.
3. Authorize the Fire Chief to, on behalf of LAFD, negotiate and execute any agreements necessary to effectuate the City's acceptance and deployment of the donated supplemental services.

FISCAL IMPACT

There is no fiscal impact to the Department's budget from the acceptance of this donation. Donations provide the necessary items meeting the needs of the respective fire stations or administration sections. Replacement or repair of items meeting City specifications and Fire Department business needs may be borne by General Fund, subject to budgetary constraints.

The Los Angeles Fire Department benefits tremendously from gracious donations and support provided by the LAFD Foundation. The LAFD acknowledges the LAFDF for its generosity.
