Subject: RESOLUTION NO. 22-10004 – PROPOSED APPROVAL OF FOREIGN-TRADE ZONE OPERATING AGREEMENT 22-9868 BETWEEN THE CITY OF LOS ANGELES HARBOR DEPARTMENT AND DSV AIR AND SEA, INC., FTZ 202, SITE 11B

Pursuant to Section 373 of the City Charter and Section 10.5 of the Los Angeles Administrative Code, enclosed for your consideration is Resolution No. 22-10004, which was approved by the Board of Harbor Commissioners at their June 8, 2022 meeting and authorizes Foreign-Trade Zone Operating (FTZ) Agreement 22-9868 between the City of Los Angeles Harbor Department and DSV Air and Sea, Inc. (DSV) for the FTZ 202, Site 11B located at 21906 Arnold Center Road, Carson, CA. 90810.

In the third quarter of 2021, DSV took over all assets from Agility Logistics Corporation, which operated under Agreement 14-3323. Due to that ownership change, a new Operating Agreement is now required. The proposed Agreement is for a term of five years with three, five-year renewal options. The Harbor Department will receive \$7,750 annually from DSV. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

1. ADOPT the determination by the Board of Harbor Commissioners that the proposed action is administratively exempt from the requirements of the California Environmental Quality Act (CEQA), under Article II Section 2(f) of the Los Angeles City CEQA Guidelines; and
2. APPROVE POLA Resolution No. 22-10004 authorizing proposed approval of Foreign-Trade Zone Operating Agreement 22-9868 between the City of Los Angeles Harbor Department and DSV Air and Sea, Inc.
