

**ORDINANCE NO. \_\_\_\_\_**

An ordinance dedicating, accepting and establishing certain real property owned by the City of Los Angeles as part of the alley south of Santa Monica Boulevard between Camden Avenue and Greenfield Avenue, all public alley of said City.

**THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:**


Section 1. The City Council of the City of Los Angeles finds that the public interest, convenience and necessity require that an easement for public alley purposes over the following described real property owned by the City be, and same is hereby dedicated, accepted and established as part of the alley south of Santa Monica Boulevard between Camden Avenue and Greenfield Avenue, all public alley of said City.

Section 2. The aforementioned easement is more particularly described as set forth in Exhibit "A" hereto.

**LEGAL DESCRIPTION**

THE SOUTHERLY 2.50 FEET OF LOTS 3 AND 4 IN BLOCK 11 OF TRACT NO. 5609, IN THE CITY OF LOS ANGELES, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP RECORDED IN BOOK 60, PAGES 34 TO 36 INCLUSIVE, OF MAPS, IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY.



Section 3. Pursuant to the provision of Section 252 of the Charter of the City of Los Angeles, this ordinance shall become effective upon publication.
