REQUEST AUTHORITY TO TRANSFER \$96,547 IN GENERAL CITY PURPOSE (GCP) FUNDING TO SUPPORT SOCIAL SERVICES FOR SENIORS

The City of Los Angeles Department of Aging (LADOA) respectfully requests authority to transfer \$96,547 in General City Purpose (GCP) funds to support Social Services for seniors as approved by the City Council (CF: 22-0600).

RECOMMENDATIONS

The General Manager of the LADOA request that the City Council, subject to the approval of the Mayor:

1. AUTHORIZE the General Manager of LADOA, or designee, to transfer \$96,547 in General City Purpose (GCP) funding to support social services for seniors;
2. INSTRUCT the Controller to:
 - a. Transfer appropriations within the Area Plan for the Aging, Title III Fund Number 395 as follows:

c. Expend funds upon proper demand of the General Manager of LADOA, or designee;

3. AUTHORIZE the General Manager of the Department of Aging, or designee, to prepare Controller's instructions and any necessary technical adjustments that are consistent with the Mayor and Council actions on this matter, subject to the approval of the City Administrative Officer, and authorize the Controller to implement the instructions.

BACKGROUND

The Department of Aging receives GCP funding (CF: 22-0600) that supports the department's various aging senior social services, including Evidence Based Programing (EBP), congregate meals, and home-delivered services. These programs provide critical services to the City's older adult residents that allow them to age in place safely and to maintain their independence.

FISCAL IMPACT STATEMENT

The proposed action involves GCP funds awarded through the City's Budget process. There is no additional impact to the City General Fund.

A copy of this transmittal is being forwarded to the City Attorney and the Council on Aging for concurrent review and approval.
