**ORDINANCE NO.** \_\_\_\_\_

An ordinance amending Subsection (a) of Section 4.322 of the Los Angeles Administrative Code, pertaining to Salary Rate for Chief Administrative Officers Upon Appointment, to provide for updated classification titles.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. Subsection (a) of Section 4.322 of the Los Angeles Administrative Code is amended in its entirety to read as follows:

(a) The methods for appointment, evaluation and adjustment of compensation for chief administrative officers shall be in accordance with Charter Section 508 and the guidelines established by the City Council as required therein.

The provisions of this article shall apply to the following chief administrative officers:

Sec. 2. This ordinance shall be effective upon publication, pursuant to Charter Section 252(g).

Sec. 3. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


